president's message: My Life, My Way

Life has a way of opening our eyes to what is important. We need to take the time to look. For me, the eye opener was a near fatal car accident resulting in life-long health and physical challenges for my mother and finding a new way of life for my family.

The word disability became real to me; it would shape my view of the world and the people in it forever. I had one wish – it was for my mother and my family to live a normal life, like other families.

It is that desire driving what we do at The Phoenix Residence and Phoenix Service Corporation; helping people to live *their* life the way they aspire.

Many believe it is impossible to live a life the way you want because of the environment where you live.

While it may be true, some providers do allow labels to dictate how supports and services are implemented within their programs.

Choice in everyday decisions about your life; a civil right!

Phoenix subscribes to a different point of view. Meaning where a person lives whether in an *Intermediate Care Facility, Adult Foster Care home, or home of their own* must not determine the life they live or their life experiences. As a provider supporting individuals with disabilities, it is our attitude about service delivery and the barriers we allow them to create that pose the problem.

People *must* have a choice in their everyday decisions; including where they live and with whom. It is a civil right! I react negatively to setting limits on individual choices – I see it as an infringement on human rights.

Over the last decade, Phoenix has attempted to break down some of the barriers created by the regulations in place to protect people but have the unintended consequence of stifling individuals from living a life of their choice. In this report, we will share with you some of the innovative ways Phoenix is meeting people where they are and helping them to get where they want to go.

Eric's House is a new program Phoenix developed for four women who are in the driver's seat of their lives; despite a moratorium on Adult Foster Care services in Minnesota. This home was developed because it was the choice of the individuals and their families. Eric's House is named in honor of Eric Schultz, one of the founding members of The Phoenix Residence board of directors.

We are proud to have been selected by Washington County and to help the individuals live a life their way, in their home. Thank you for helping us to help others with "My Life, My Way."

GERTENS



ADVOCACY

"The 5% Campaign", launched in 2013, is a nonpartisan coalition of Minnesotans working together to secure legislators support for a 5% rate increase for Home and Community Based Services (HCBS).

The year 2013 marked the fifth consecutive year the services for people with disabilities did not receive a rate increase. These critical services and supports allow people to be more independent by providing staffing and transportation promoting active living in the community.

The campaign was a success; passing the full 5% during the 2013/2014 session. The 5% Campaign was a move in the right direction however we need to

continue the momentum and contact legislatures about supporting HCBS in the years to come.



Music therapy has many benefits to a wide range of individuals; specifically adults with physical and development disabilities. During a group music

therapy session, the music acts as a co-therapist stimulating social interactions between participants, creating rhythm and structure for movement, singing and speech, and stimulating their cognition.


Andy lives a life his way —

The Phoenix Residence is happy to announce the opening of our 19th home, *Eric's House*. Eric's officially opened on March 5, 2014 and is named in honor of Eric Schultz, a founding board member since 1977. Phoenix Residence was selected by Washington County in response through an RFP process.

Eric's House is certainly unique in many ways. The house, only staffed and occupied by women, was built to meet the needs of the individuals with the understanding of how they would like to access *their* home. Technology has been integrated throughout the house and boasts many accessible features such as a walk-in whirlpool tub, a low profile shower door, adjustable countertops in the bathroom, and a ceiling lift system in two bedrooms and the living area.

The many accessible features in Eric's House have enabled everyone to be in the driver's seat of their own lives; promoting independence.

An induction cooktop was included in the kitchen, providing a safe cooking experience. The dining room includes a height-adjustable table along with chairs complete with in-line casters. Automatic door openers have been added to several doors allowing for individuals to move freely throughout the house without caregiver assistance. The many accessible features in Eric's House have enabled everyone to be in the driver's seat of their own lives; promoting independence.

ADEYEMI DEAN


