The Phoenix Residence, Inc. provides...

- Services without discrimination based on race, color, national origin, sex, age, or disability.
- Appropriate accommodations for people with disabilities in a timely manner and free of charge when they are needed to perform services. Appropriate accommodations include assistive devices and services, interpreters and information in alternate formats.
- Timely language assistance services for people with limited English proficiency (LEP) free of charge when they are needed to perform services. Language assistance services include translated documents and oral language interpretation.

How to File a Complaint

You can file a complaint in any of the following ways:

Time Limit for Filing

Complaints generally must be filed within 180 days of the date you knew that the discrimination occurred. OCR may extend this deadline for good cause. [[HHS.gov](https://www.hhs.gov)]
